Sub : Police Estt:- Avoidance of Diversion of Police personnel from Local Police Stations - transfer of Police Personnel (on working arrangement) to DHQ Reserve - Orders issued - Reg.

Ref : 1) PHQ Circular No. 33/2011 dated 18/10/2011  
2) PHQ Message No. S2-91578/2011 dated 16/11/2011  
3) DO No. 333 / 2017 C dated 8.5.2017

Specific instructions are issued for avoiding diversion of police personnel from local police stations by way of working arrangements, as per the PHQ Circular and message read above. In exceptional cases when the police personnel are to be posted on working arrangement basis, they are to be transferred and posted to the District Headquarters Reserve before they are relieved from local police stations on working arrangement basis, as per the orders cited above. The resultant vacancy in the Police Station shall be filled up as per norms so that work of the Police station shall not suffer.

In the circumstances mentioned in the PHQ orders cited above, the following Police Personnel who are on working arrangement to various units are posted to DHQ Reserve with immediate effect.
