16	Brief of the case	<p>An unidentified dead body of a male person , suspected that of a victim of Okhi cyclone , has been recovered from the Arabian sea by Indian Navy ship on 27.12.2017 FN, has been handed over to Fisheries Enforcement wing Kannur . A case has been registered at Coastal Police Station Thalassery on 27.12.2017 as Crime No. 02/2017 U/S 174 CrPC as per the statement of by Sri.Shinil CPO 6777 of Fisheries Enforcement wing. The inquest and post-mortem has been carried out from the Pariyaram Medical College Hospital and the DNA sample has also been collected. The body is keeping at Kannur Dist. Hospital Mortuary for identification.</p> <p><u>Description of Dead Body</u></p> <p>A fully decayed body of a middle aged person having 153 cm height. Worn out pieces of Maroon shirt of XXL size with a Collar Sticker titled ' Emirates The Flying Fashion' on it. A blue colour under wear with a name tag 'V-Star'. The first molar teeth of lower jaws has been removed earlier and the pan stain has been seen on remaining teeth.</p>
